## Mr J. W. Broadley - Paeroa

Re Administrative procedures followed by Apiaries Advisory Committee Mr Broadley complained that he had not been able to secure an appointment with the Committee and also that a meeting of all the interested parties be convened.

#### Resolved:-

- 1) "THAT A COPY OF MR BROADLEY'S LETTER BE ATTACHED TO THE LETTER TO BE SENT TO THE MINISTER OF AGRICULTURE AND THAT IT BE SUGGESTED THAT IT WOULD SEEM DESIRABLE FOR THE COMMITTEE TO BE ADMINISTERED AND SERVICED BY THE HAMILTON OFFICE OF THE MINISTRY."
- 2) "THAT THE GENERAL SECRETARY WRITE TO MR BROADLEY AND ASK IF COPIES OF RELEVANT LETTERS COULD BE MADE AVAILABLE TO THE EXECUTIVE."

# DISCUSSION WITH MESSRS IAN FORBES AND E. SMAELLIE MINISTRY OF AGRICULTURE AND FISHERIES

The President in welcoming Messrs Forbes and Smaellie thanked them for making themselves available and he said it gave him pleasure to congratulate M r Forbes on his new appointment and all would wish him a successful term in his new post.

Mr Forbes returned thanks and said be would be glad to work with Association in furthering the Interests of the beekeeping industry.

The following topics were then raised and discussed.

# 1) Honey Export Regulations - Revision and updating

Mr Smaellie advised that one of the points of concern was the definition to be applied to honey and honey dew. The D. S. I. R. had not so far been able to suggest a convenient supporting analysis. The intention now was to examine a more simple approach.

# 2) Membership Apiaries Advisory Committee

The question of a replacement for the late Mr Forsyth was raised and Mr Forbes indicated the matter was in hand.

The question of Mr Robinson not being invited to attend Committee meetings drew the response that his appointment had not been gazetted and the reasons for the delay were not forthcoming - (refer earlier minute)

# 3) Booklet - N. Z. Beekeeping

The Executive expressed pleasure at its availability. Mr Smaellie advised that a new booklet would be produced in due course - publication date was extected to be about five years hence.

## 4) Research into Sugar Feeding

It was noted that a good deal of Research material was available and Mr Forbesundertook to have this assembled and made available.

# 5) Replacement of Apiary Advisory Officers

Mr Forbes reported that all aspects of Government expenditure was under close scrutiny and some changes in current servicing arrangements could well prove necessary.

The wider use of part time officers was one possibility that would need to be further examined.

# 6) Queen Rearing Courses and the Like

The Ministry Officers advised that it was policy to offer such courses and it was the intention to continue especially as farming education was a strong feature of Government policy.

# 7) Dominion Seminar - 1977

Mr Smaellie indicated that thought was being given to sponsoring the seminar just prior to or following Apimondia in October 1977. The Seminar was scheduled for the South Island but no venue had been set.

The timing of the Seminar was debated at some length, it was the view of some members that it may not be satisfactory to have the seminar in October 1977 because of the double commitment many beekeepers would have.

The disinability of running it in with the Conference found favour and it was agreed this approach should be studied further.

## 8) Schedule of Past Publications

Mr Forbes undertook to make a schedule available in due course.

Messrs Forbes and Smaellie then left the meeting.

#### PROPOSED NEW RULES FOR THE ASSOCIATION - SPECIAL GENERAL MEETING

The Executive roted that acting on the advice of the Association's Solicitor the special meeting held on 24 March 1976 was unable to pass a resolution adopting the proposed new rules. The point raised was a technical one but none-the-less had to be recognised.

The 24 March meeting had been able to consider and amend the draft presented to the meeting and a schedule of these amendments had been prepared by the Solicitor together with a fresh special meeting notice.

It was duly resolved:-

- 1) "THAT THE NOTICE CONVENING A FURTHER SPECIAL GENERAL MEETING OF THE ASSOCIATION BE SENT BY POST TO ALL MEMBERS RECORDED ON THE MEMBERSHIP SCHEDULE AT THE DATE OF THE MAILING OF THE NOTICES."
- "THAT THE NOTICE PROVIDE BACKGROUND TO THE NEED TO CONVENE ANOTHER SPECIAL GENERAL MEETING."

# ANNUAL ACCOUNTS FOR PERIOD ENDED 31 DECEMBER 1975 - BALANCE DATE

In attendance Mr C. J. Read Accountant.

Draft accounts and balance sheet for the financial period ended 31 December 1975 were presented and elaborated upon by Mr Read. Following questions from members it was resolved:-

"THAT THE DRAFT ACCOUNTS COVERING THE FINANCIAL ACTIVITIES OF THE ASSOCIATION FOR THE EIGHT MONTH PERIOD ENDING 31 DECEMBER 1975 BE RECEIVED AND ADOPTED AND THAT THEY BE SUBMITTED TO AUDIT ACCORDINGLY."

## re Library Account

Mr Read suggested that it could be more convenient to all those concerned if the separate Library Post Office Account were closed and the Committee given a maximum spending allocation with the payments being effected by Head Office.

It was agreed that up to \$200 could be placed on allocation and it was left to Mr McKenzie to discuss with the Committee and report back.

# FEDERATED FARMERS

The President reported on his attendance at the February meeting of Dominion Council and in particular on the question of Federation income based on live stock levies. There had been a proposal advanced for a levy to be struck on all farm produce.

The President in summing up his attendance at the meeting said he felt it had been worthwhile from an industry point of view.

It was duly resolved:-

"THAT THE PRESIDENTS REPORT BE RECEIVED."

#### EXPORTS BY PRIVATE PACKERS

The Executive consideration of the subject was based on a letter under date of 22 March 1976 received from the Honey Marketing Authority and also on Remit No. 19 passed at the 1975 conference.

The Authority in its letter sought Association opinion on a series of criteria it felt should attach to private packer exports.

These were considered in the order set down in the letter.

- This clause was a broad statement of policy objective in which the Executive concurred.
- 2) This clause suggested that consignments be 10 tonnes.

The Executive considered that the quantity should be up to 10 tonnes per shipment or consignment. It was noted and supported that consignments be in the form of retail packs only.

3) Lodgement of Applications and details related thereto.

The Executive while recognising that a period of 30 days could be necessary felt that a lesser time scale could well be appropriate.

- 4) Re selling prices. The Executive considered that all quotations and/or negotiations should be subject to H. M. A. approval.
- 5) Re supply of Bills of Lading etc concur.
- 6) Re Advice on sales proceeds concur.

The following additional points were agreed by Executive for forwarding to the Authority.

- a) That each Private Exporter be required to establish a Bond with the Authority in support of compliance with the conditions laid down a figure around \$200 could be appropriate.
- b) That a H. M. A. administration fee be charged for each application. This is considered desirable to ensure that the non-exporting suppliers are not meeting costs on honey not the property of the Authority.
- c) That consignment, date and origin codes be affixed to each honey container to ensure that it can be checked back should the need arise.
- d) That the packs used be subject to H.M.A. approval so as to ensure the protection of the name of New Zealand honey in export markets.
- e) That an export levy on all honey exported by private packers under this general arrangement be subject to a Stabilisation levy assessed on an adjustable percentage scale.

This is considered basic to the whole proposal so long as a honey price payout ceiling applies to honey supplied to the authority. The intention is that the proceeds of the exports levy would be credited to the Stabilisation fund.

- f) That permits to export be confined to Commercial members of the Association i.e. the payers of Hive Levy.
- g) The Executive Committee does not consider the Licensing of Private Packers to be necessary the suggested Bond system should suffice.

# Broader Aspects of Honey Exports

Mr Berry in raising the question said there would be general acceptance that honey price stabilisation should remain a pre-requisite and be accepted a Base Pricing factor. He also raised the question of small export consignments of bulk honey by private packers and suggested a number of ways in which this concept might be approached.

The Executive debated the broad issues involved at length and finally it was moved:-

1) "THAT THE EXECUTIVE COMMITTEE CONFINE ITS REPLY TO THE AUTHORITY WITHIN THE TERMS OF REMIT NO. 19 PASSED AT THE 1975 CONFERENCE."

Stuckey/Berry Carried

2) It was further resolved:-

"THAT THE EXECUTIVE ALSO POINT OUT TO THE AUTHORITY THAT IN ITS VIEW THE CONSEQUENTIAL EFFECTS AND REQUIREMENTS IN RESPECT OF FUTURE HONEY MARKETING AND STABILISATION POLICIES INDICATES THAT MUCH DEEPER STUDY OF THE QUESTION WOULD APPEAR DESIRABLE AND NECESSARY: ACCORDINGLY IT IS PROPOSED TO INCLUDE THIS RESOLUTION ON THE AGENDA OF THE PROPOSED JULY JOINT MEETING OF THE TWO BODIES."

# THE BEEKEEPER

In Attendance the Editor Mr Trevor Walton.

The Executive reviewed with Mr Walton various aspects of the journal production.

The Executive resolved:-

"THAT IT PLACE ON RECORD ITS COMPLETE CONFIDENCE IN THE EDITOR AND THAT IT CONGRATULATE HIM ON THE QUALITY CONTENT AND PRESENTATION OF BEEKEEPER."

Members indicated that they had received many complimentary comments and the great majority of members seemed well pleased with their journal

# GOVERNMENT POLICY TOWARDS INDUSTRY

5 p. m. Friday 4 June 1976.

The President in introducting the question advised that the Minister had requested that the Association give thought to the areas where it considered government policies could be directed in promoting the industry and maximising its role in agriculture.

After full discussion and consideration it was resolved that the following series of questions be put to branches for consideration and reply.

- 1) The Principal areas available for further development via beekeeping in the Branch district.
- 2) That factors inhibiting development of beekeeping in the Branch district.
- 3) The Principal factors limiting the viability of commercial beekeeping.
- 4) Detail any special sectors where government assistance in appropriate manner could benefit the industry.
- 5) Is a continuing honey price smoothing policy seen as being a basic factor in the economic welfare of the industry.
- 6) Should Water Boards/Catchment Boards/Counties/Farmers be given special incentives via subsidy or tax concession to forestate with suitable pollen or nectar bearing trees (please give examples)

# BASE PRICE FOR HONEY 1976

A copy of the letter under date of 13 March 1976 sent by the Minister of Agriculture to the Chairman of the Honey Marketing Authority authorising a basic increase in the Base Price for honey of 3 cents a lb ( from 54 cents to 57 cents) was tabled.

In discussing the matter the Executive noted with pleasure that the cost increases advised to the Minister had been recognised at least in part. The view of the Executive remained that a near end of year discussion should be held with the Authority in order that a composite submission on honey price could be developed and so ensure an earlier announcement.

It was duly resolved:

"THAT THE LETTER BE RECEIVED."

# LOCAL MARKET HONEY MARKETING

The general topic was introduced by the President and subsequently debated by members. The debate ranged over a wide number of topics related to the question and concluded by the following motion being resolved:-

- 1) "THAT IT BE RECORDED THAT THE EXECUTIVE COMMITTEE DISCUSSED IN GENERAL TERMS THE LOCAL MARKET HONEY SITUATION AND FORMED THE VIEW THAT BOTH BEEKEEPERS AND PACKERS SHOULD EXAMINE THEIR HONEY PRICING POLICIES SO AS TO ACHIEVE A HIGHER RETURN FROM LOCAL SALES: IN GENERAL IT WOULD SEEM THAT "AT GATE" PRICES OULD BE SIGNIFICANTLY INCREASED WITHOUT DETRIMENT TO SALES."
- 2) "THAT THE ASSOCIATION SEEK FROM THE H. M. A.
  A DETAILED ANALYSIS OF LAST YEAR'S PROCESSING
  AND PACKING COSTS AS THESE APPLIED TO BOTH
  THE LOCAL AND EXPORT MARKET SALES."

# POLICY ATTITUDE ON RESTRICTED ZONES RESULTING FROM TUTU TOXININ HONEY

The Executive in considering the several questions relating to the broad issue of Restricted Zones considered it desirable to set down in resolution form its policy attitude for the benefit of the Associations representative on the Apiaries Advisory Committee Mr Ray Robinson.

It was accordingly moved:-

- 1) "THAT IT BE RECORDED THAT IT BE EXECUTIVE COMMITTEE POLICY THAT ANY RESTRICTIONS IMPOSED BE REASONABLE AND CONSISTENT WITH THE PROTECTION OF PUBLIC HEALTH."
- 2) "THAT THE EXECUTIVE COMMITTEE DOES NOT SUPPORT THE PRODUCTION OF COMB HONEY IN RESTRICTED ZONES DURING THE RISK PERIODS.
- "THAT IT IS NOT SATISFIED AT PRESENT THAT THE INCLUSION OF EXTRACTED HONEY IN THE RESTRICTION IS JUSTIFIED OR NECESSARY."
- 4) "THAT AREAS INCLUDED IN RESTRICTED ZONES FOR BEEKEEPING SHOULD BE MORE PRECISELY DEFINED."

The President extended a welcome to those present and especially those members who had travelled long distances to be in attendance.

# NOTICE OF SPECIAL GENERAL MEETING

Mr McKenzie in his capacity as delegate representing the South Canterbury Branch advised that the Branch had resolved to contest the point that 30 days notice had been given to all members as required under the present rules.

The President reported to the meeting that the notice had been placed in the March issue of Beekeeper which members would have received early in March: further Branch Secretaries had received a copy of the notice very early in February.

The question was raised by Mr Ashcroft as to who in fact were members.

The President then invited Mr Hardie Boys to give an opinion on the point: Mr Hardie-Boys then pointed out that as the adequacy of notice had been questioned and action threatened there was little that could be done and it would have to be accepted that this special meeting could not adopt the proposed new rules.

The President thereupon ruled:-

"THAT NO MOTION TO ADOPT THE NEW RULES WOULD BE PUT TO THE MARCH 24 SPECIAL MEETING AS HAD BEEN INTENDED."

The President in ruling observed that the cost to Association in giving notice of and holding another special general meeting would be substantial.

The meeting then proceeded to consider the various suggestions received from Branches in respect of the proposed new rules and the following is a schedule of the Amendments agreed to.

The meeting divided on only two fundamental matters namely:-

- a) Whether the election of the Executive should be on a postal ballot basis and
- b) When it should be competent for the Annual Meeting and/or Conference to direct the Executive to take some defined action as expressed in the form of a remit or resolution.

The Noting in each case strongly supported the proposals as outlined in the Draft Rules.

The schedule of amendments agreed by the meeting are as follows:-

# 1. Rule 2

- (i) Replace definition of "hive levy" with the following:

  "Hive Levy" means the annual levy payable by producers to
  the Honey Marketing Authority in accordance with the
  Regulations.
- (ii) Add new definition:

  "The Regulations" means the Honey Marketing Authority Regulations
  1975, or any regulations in amendment or substitution therefor

## 2. Rule 4(h)

Delete "lend and/or. "

# 3. Rule 4 (1)

Amend "Institute" to "Association".

### 4. Rule 5 (a)

Replace with the following:

There shall be three categories of membership, namely

- (i) Ordinary Members;
- (ii) Commercial Members:
- (iii) Life Members.

# 5. Rule 6(a) (i)

Replace with the following:

Ordinary membership shall be open to:

(i) Any beekeeper whose apiary is registered under the Apairies Act 1969, but who is not liable to pay a hive levy.

#### 6. Rule 10

(i) Amend heading to read:

Termination and Restriction of Membership Rights.

- (ii) In the second-to-last line of paragraph (a) amend "suspension" to "restriction".
- (iii) Replace paragraph (c) with the following:

A commercial member shall cease to be a member if he dies or ceases to be qualified or if the Executive is satisfied that he has failed to pay the hive levy as and when due.

## 7. Rule 13

Replace with the following:

The President and Vice-President shall be elected at the Annual Meeting of the Association from the six numbers of the Executive elected in accordance with Rule 14. Should there be an equality of votes, the result shall be decided by lot. Those elected shall take office immediately upon their election.

## 8. Rule 14

(i) Replace paragraph (e) with the following:

For the purposes of the election an ordinary member shall have two votes and a commercial member shall have one vote for each 25 hives or part thereof on which hive levy for the current year has been paid with a maximum of 100 votes. Hive levy shall be deemed to have been paid for the purposes of this Rule if payment thereof has been deferred by the Authority in accordance with the Regulations.

(ii) Add to paragraph (g):

... or on the requisition of four members of the Executive.

# 9. Rule 16

(i) Add new subparagraph (b) (vii) as follows:

To elect the President and Vice-President.

- (ii) Consequentially renumber subparagraphs (vii) (vii) and (ix) to become (viii) (ix) and (x): also in the proviso renumber (viii) and (ix) and (x).
- (iii) In paragraph (c) replace the word "poll" with the words "show of hands or secret ballot".
- (iv) Replace paragraph (d) with the following:

Notwithstanding the foregoing, the President or the Executive or the Annual Meeting may at any time refer any question to the Conference of Branch Delegates.

# 10. Rule 17

- (i) In subparagraph (f) (i) delete the words "remit in".
- (ii) Add to the end of paragraph (f) the following:

The votes cast by each delegate shall be displayed to the Conference.

### 11. Rule 18.

At Branch meetings each member of the Branch present in person or by proxy shall have one vote except that on a poll or any remit to the Conference of Branch Delegates or any business for consideration at a Special Meeting members healt have the same voting entitlement as under Rule 14 (e).

Replace with the following:

All postal polls shall be conducted by the Executive Secretary and the result thereof shall, as soon as practicable after the poll has been taken, be notified by him to the membership of the Association by an entry in an issue of the Association's journal.

- (ii) In paragraph (b) amend "General to "Special"

MINUTES OF THE 1976 ANNUAL MEETING AND CONFERENCE OF DELEGATES OF THE NATIONAL BEEKEEPERS' ASSOCIATION (INC.) HELD IN SENIOR CITIZENS HALL, TAUPO ON WEDNESDAY, THURSDAY AND FRIDAY THE 28TH, 29TH AND 30TH JULY 1976 COMMENCING AT 9 A.M. ON WEDNESDAY THE 28TH JULY 1976.

#### PRESENT:

#### OPENING PRAYER:

The Chairman read the Opening Prayer to Conference.

# WELCOME TO MEMBERS, DELEGATES AND VISITORS:

The Chairman extended a warm welcome to all present and expressed the hope that everyone would participate in the Conference both businesswise and socially. The host branch had organised a good programme and he was sure all would take away happy memories of the 1976 Taupo Conference.

#### WELCOME TO TAUPO:

His Worship the Mayor of Taupo, Mr Clem Currie thanked the Association for deciding upon Taupo as their Conference venue and expressed the hope that all attending would take full opportunity to visit the tourist attractions of the Taupo area. During the course of his address Mayor Currie referred to the growth of Taupo and its growing importance in agricultural terms. He also referred to the apparent lack of consumer promotion of honey on the local market and commended the Conference to look at this aspect of their industry.

#### REMIT NO. 3 - NELSON

Mr White sought leave to withdraw but Conference did not concur.

The Remit was amended to read

"That the Executive Committee review its policy and formula for financing Branch funds with a view to making more realistic payments to Branches."

It was mutually agreed that

# REMITS 4, 5, and 6 be taken together.

Remits 4 and 5 were later withdrawn in favour of Remit No. 6 amended as under

"That this Conference recommends that the Executive Committee confer with the H.M.A. and appoint a Committee to carry out an investigation into the feasibility and desirability of amalgamating the N.B.A. and the H.M.A. as one producer body and report its findings to Branches prior to the 1977 Conference."

Moved Messrs Heineman/Bray and CARRIED unanimously.

REMIT NO. 7 - MR R. JANSEN Lapsed for want of a seconder.

# REMIT NO. 8 - SOUTH CANTERBURY

The Remit read

"That the Executive have legislation put through Parliament so that the N.B.A. can operate the Hive Levy scheme."

Moved Messrs S. Lyttle/McKenzie and LOST 9 votes to 5 votes.

## REMIT NO. 9 - SOUTHLAND WITHDRAWN

#### REMIT NO. 10 - SOUTHLAND

The Remit read

"That Conference protest at the unsatisfactory condition of used containers supplied to beekeepers by the H.M.A."

Moved Messrs Clissold/Glynn and LOST.

#### REMIT NO. 11 - AUCKLAND

The Remit read

"That this Conference wishes the President to allocate time to the Chairman of the H.M.A. to outline the Kimpton Agreement to the members present, and to explain why the H.M.A. members feel it should continue and that the President should then allow discussion on this Agreement."

Moved Messrs Stuckey/Bellin.

The remit was discussed for a considerable period - copies of the Agreement were made available by Mr Poole. The matter was allowed to rest.

#### REMIT NO. 12 - SOUTHLAND

The Remit as amended read

"That Conference request the H.M.A. that in future the Base Price be recommended to the Minister as early as possible, preferably not later than mid-December."

Marshall/Ashcroft and (ALKIED.

# REMIT NO. 13 - SOUTH CANTERBURY

The Remit read

"That all honey produced, except comb honey and a quantity reserved for sale from the honey house, be first offered to the H.M.A.; the Authority to have the right to accept or reject the honey, to dispose of the honey as it appears to the best advantage of the supplier, or to direct the supplier of the honey to make it available to whom-so-ever the Authority directs."

Moved Messrs S. Lyttle/H. Cloake and LOST on Poll 230 For 3936 Against.

#### REMIT NO. 14 - CANTERBURY

The Remit read

That the H.M.A. be reconstituted to act purely as a Regulatory Body for the beekeeping industry. Its functions should be:

- To act as agents for exporting honey.
- To license packers and exporters.
- 3. To set minimum export prices for both packed and bulk honey.
- 4. To establish and update costs of production from time to time and notify the industry of such changes which would reflect in local prices.

- 5. To negotiate and arrange temporary (i.e. seasonal) finance for producers.
- 6. To merge with the N.B.A."

Moved Messrs Bray/Hantz and declared LOST on a Poll For 1544 Against 2388

At this point, 4.20 p.m. the President, Mr I.J. Dickinson assumed the Chair. A motion of appreciation to Mr P. Berry for acting as Chairman of Conference - carried with acclamation.

#### REMIT NO. 15 - MR R. JANSEN

The Remit as amended read -

"That this Conference requests an inquiry by an independent authority into the feasibility of the H.M.A. becoming a Regulatory Board only, thus offsetting increasing operating costs and diminishing returns to the beekeeper."

Moved Messrs Jansen/Heineman and CARRIED on a Poll 2305 to 1808 Votes.

# REMIT NO. 16 - SOUTH CANTERBURY

TherRemit as amended read

"That all packers who sell to the retail trade be licensed by the Health Department."

Moved Messrs S. Lyttle/P. Lyttle and on being put was LOST.

# REMIT NO. 17 - CANTERBURY

The Remit read

"That this Conference supports the principle of the licensing of honey packers."

Moved Messrs Hantz/Bray and LOST.

#### REMIT NO. 18 - SOUTH CANTERBURY

The Remit read

- "(a) That an Industry Equalization Reserve Fund be established for the purpose of guaranteeing a payout price to the producer relative to the cost of production.
- (b) That to finance the Industry Equalization Reserve Fund a levy be struck and payable on all honey sold.
- (c) That the amount of the levy be three cents per kilogram of honey sold but this amount be reviewed from time to time and varied as required to maintain the Fund at a suitable level."

Moved Messrs S. Lyttle/H. Cloake and LOST 13 to 2 Votes.

# REMIT NO. 19 - AUCKLAND Withdrawn

## REMIT NO. 20 - SOUTHLAND

The Remit read

"That this Conference recommend that a committee representative of all sections of the the beekeeping industry be formed:

- (a) To investigate and assess the cost of honey production so that in relation to such costs, a more realistic selling price can be established.
- (b) To investigate the fesibility of all local honey sales being subjected to some form of control, thus ensuring stability of prices."

Moved Messrs Clissold/Herron and LOST 11 Votes to 3.

#### REMIT NO. 21 - HAWKES BAY

The Remit read

"That Conference reaffirm the Association's support for the principle of allowing exports of retail packs of extracted honey by exporters other than H.M.A., but subject to H.M.A. control."

Moved Messrs Marshall/Stuckey and CARRIED 13 Votes to 1.

# REMIT NO. 22 - SOUTH WESTERN DISTRICTS

The Remit read

"That this Conference reaffirms the remit passed at last year's conference at Timaru relating to the export of packed (retail) honey by private packers and would like to know what steps have been taken by the H.M.A. towards implementing this remit.

Moved Messrs Bromell/Morris and CARRIED unanimously.

# REMIT NO. 23 - MR R. JANSEN

The Remit read

"That this Conference reaffirms last year's remit calling for private exports of packed honey and urges early implementation of this policy."

Moved Messrs Jansen/Morris and CARRIED unanimously.

REMIT NO. 24 "- NORTH OTAGO

WITHDRAWN.

## REMIT NO. 25 - HAWKES BAY

The Remit read

"That Conference supports the principle of exports of appropriate quantities of bulk extracted honey by exporters other than the H.M.A. but subject to H.M.A. control."

Moved Messrs Marshall/Ashcroft and CARRIED on a Poll Vote FOR 2865 AGAINST 1169.

REMIT NO. 26 - CANTERBURY

WITHDRAWN.

## REMIT NO. 27 - CANTERBURY

The Remit read

"That the Executive take immediate and strong action to establish the cost of production of honey in New Zealand based on current costs and average New Zealandwide production."

Moved Messrs Bray/Ecroyd and LOST 14 Votes to 1 Vote.

## REMIT NO. 28 - SOUTH CANTERBURY

The Remit as amended read

"That the Executive of the N.B.A. arrange with the Economics Section of the Ministry of Agriculture to have a survey on the beekeeping industry taken out urgently. The survey be of sufficient depth to indicate possible future methods of beekeeping viability."

Moved Messrs S. Lyttle/Bray and CARRIED 14 Votes to 1 Vote.

#### REMIT NO. 29 - SOUTH WESTERN DISTRICTS

The Remit read

"That this Conference views with great concern the vacancy left by the late Mr Dick Hobbs and strongly urges the Ministry of Agriculture and Fisheries to appoint a further instructor to fill this position."

Moved Messrs Bromell/Marshall and CARRIED unanimously.

REMIT NO. 30 - HAWKES BAY WITHDRAWN.

#### REMIT NO. 31 - SOUTH WESTERN DISTRICTS

The Remit as amended read

"That the Ministry of Agriculture & Fisheries be urged to publish and update "Beekeeping in New Zealand".

Moved Messrs Bromell/Morris and CARRIED unanimously.

# REMIT NO. 32 - SOUTH CANTERBURY

The Remit read

That the Minister of Agriculture be asked to approve Rural Bank finance for beekeeping development, with hives being accepted as security for loans."

Moved Messrs S. Lyttle/McKenzie and CARRIED 13 Votes to 2 Votes.

#### REMIT NO. 33 - MR R. JANSEN

The Remit as amended read

"That Government investigate the value of the pollinisation service provided by beekeepers to the agricultural industries with a view to continuing the availability of loans as was the case this year."

Moved Messrs Jansen/Heineman and CARRIED unanimously.

#### REMIT NO. 34 - NORTH OTAGO

The Remit read

"That apiarists be enabled to purchase farm bikes for use between apiaries, and qualify for rebate on purchase as enjoyed by other farmers."

Moved Messrs Heineman/Glynn and CARRIED 10 Votes to 3 Votes (2 absentions).

# REMIT NO. 35 - BAY OF PLENTY

The Remit read

"That the N.B.A. continue to oppose the proposed scheme to clear fell the native bush on the Kaimai Range and other bush areas for the purpose of planting pine forest."

Moved Messrs Barrow/Glasson and CARRIED unanimously.

# REMIT NO. 36 - HAWKES BAY

The Remit as amended read

"That this Conference agrees that it would be desirable to import Queen Bees from Tonga and requests the Minister of Agriculture to proceed with the necessary checks to ensure that no harmful diseases, parasites or undesirable characteristics are imported into New Zealand."

Moved Messrs Heineman/Gibbon and CARRIED on a poll Vote 2090 Votes to 1134 Votes.

(Minute Note: The original remit was moved Messrs Marshall/Ward but the above amendment was later accepted and adopted.)

"That Executive be urged to continue its interests and representation on the Apiaries Advisory Committee."

Moved Messrs Herron/Clissold and CARRIED unanimously.

"That the postal authorities be asked to depict a honey bee on a postage stamp."

Moved Messrs S. Lyttle/Bray and CARRIED unanimously.

## REMIT NO. 39 - CANTERBURY

The Remit read

"That this Conference express its appreciation" to Mr E.A. Smaellie for the services rendered to this industry over many years."

Moved Messrs Bray/Poole and CARRIED by acclamation.

Mr Smaellie suitably acknowledged the Conference resolution.

"That this Conference supports the present guaranteed Base Price System and recognises the fact that the continued operation of this scheme depends on the existence of some form of stabilisation levy: accordingly Conference supports in principle the introduction of a Stabilisation levy and requests the Executive Committee in consultation with the H.M.A. to determine how best such a levy should be implemented and operated."

Moved Messrs Ecroyd/ not seconded and LOST 39 Votes to 21 Votes.

#### NOTICE NO. 2

"That this Conference asks the Executive Committee to approach the Ministry of Works to see if it is possible to have the mowing of road edges delayed until early December."

(Note in Support: At present a lot of early clover flower is being cut which is available to bees for nectar and pollen before clover comes into flower in farm pastures.)

Moved Messrs Bird/Robinson and CARRIED unanimously.

## LIFE MEMBERSHIPS

The President reported that the Executive had considered the life membership nominations received from Branches and then called upon the respective Branch delegates to speak in support of each and move the appropriate motion.

The following were proposed for Life Membership.

- (1) MR JACK GLYNN Moved Messrs Clissold/Herron.
  - On being put the motion was carried unanimously and the President presented a Life Membership Certificate to Mr Glynn.
  - On receiving the certificate Mr Glynn thanked the Association for the honour bestowed upon him.
- (2) MR W.I. HAINES Moved Messrs Gavin/Bird. The motion was carried unanimously and in the absence of Mr Haines due to ill health Mr Gavin accepted the Certificate from the President on his behalf.
- (3) MR HARRY CLOAKE Moved Messrs S. Lyttle/McKenzie. After a number of members had spoken in support the motion was put and carried unanimously.

# ANNUAL REPORT - APIARY SECTION MINISTRY OF AGRICULTURE - Mr E.A. Smaellie

Mr Smaellie in presenting what would be his last report to the Annual Meeting and Conference thanked the Association and its members for their co-operation with him and his staff over so many years.

The report which had been circulated beforehand was then used as a basis for a question and answer session.

It was duly resolved

"That the annual report of the Apiary Advisory Section be received."

CARRIED by acclamation.

#### PRESENTATION TO MR E.A. SMAELLIE

The President on behalf of the Association thanked Mr Smaellie for the work he had done for the industry over a very long period. Mr Smaellie had served the interests of beekeepers in a number of capacities and had established a friendly and sound working relationship with beekeepers everywhere.

The President wished Mr Smaellie a long and enjoyable retirement.

He then asked Mr Smaellie to accept a silver tray and server as a mark of the esteem in which he was held by the Association and its members.

The presentation was supported by acclamation.

In acknowledging the presentation Mr Smaellie traced his early association with the industry and said he valued the many friendships he had made. He thanked all for the presentation and said it would be a permanent reminder of his link with the industry.

Mr P. Berry was nominated by Messrs Marshall/Morris and there being no further nominations was duly declared <u>elected</u>.

Mr Berry then assumed the Chair and thanked members for their vote of confidence.

The Annual Meeting recorded a unanimous vote of thanks to Mr Dickinson for his services to the Association during his four year term as President.

# APIMONDIA CONGRESS - ADELAIDE OCTOBER 1977

Mr Graeme Walton in reporting said the N.Z. Bee Research Association and the N.B.A. had decided to co-sponsor a tour to the Congress. There appeared to be three period terms for tours - 8 days, 14 days and 21 days. The Annual Meeting favoured the 14 day term visit.

In all, between 17 and 20 of those present expressed interest. Mr Walton advised that further details would be reported in due course.

## FEDERATED FARMERS - 1976 DOMINION CONFERENCE AGENDA

The Executive Secretary reported that he had attended some of the Annual Conference sessions - no matters of special concern to the Association had arisen.

There still appeared some doubt as to who was the Association's Representative on the Federated's Dominion Council.

It was agreed that the draft should be discussed with the Authority the following day when Ministry Officers would also be in attendance.

The following points were noted for later discussion.

- (1) Copy of Draft to Comb Honey Producers! Association supported.
- (2) Definition of Honey -
  - (a) Does it include heather, manuka and like honeys
  - (b) re Comb honey re "thin supers" check as to need for this qualification
  - (c) (V1) manufacturing grade provisions
- (3) Clause 5 (2) Moisture suggest
  - (a) 21 parts per centum for ordinary honey
  - (b) 23 parts per centum for heather honey
- (4) Re Bulk honey clarify in respect of "crushed combs"
- (5) Page 4 reverse Clauses 5 and 6
- (6) Clause 24 (1) re Grading fees

Raise question of fees as they could apply to packers distant from main grading centres.

(7) Clause 17 (1) Supplier or Producer instead of "owner".

Part 2 - 1. A. re pollen. Cells of pollen - seek clarification.

New Clause 1 (E) Comb honey with natural pollen.

Clause 5 - check suggested minimum.

Clause 9 - Suggest 250 kg as alternative to 500 kg.

Mr McKenzie tabled correspondence he had received from a Spanish contact and it was agreed that the organisation be placed on the Beekeeper free mailing list.

Tuesday 27th July - In the absence of the President due to indisposition Mr P. Berry assumed the Chair.

## CONSIDERATION OF CONFERENCE REMITS

The Executive discussed the remits on the Conference order paper and also considered the order in which these might best be taken. No firm decisions were taken in the matter except that it was felt that remits 4, 5 and 6 should be given a measure of priority.

## JOINT MEETING WITH HONEY MARKETING AUTHORITY

The Authority was represented by the Chairman, Mr R.F. Poole, and Messrs Ecroyd, Hayman and the General Manager, Mr Curtis Wicht.

Also in attendance were Messrs Ian Forbes and Eric Smaellie, Ministry of Agriculture.

Mr Berry welcomed all to the meeting and advised that a sudden attack of flu prevented Mr Dickinson being present.

#### The following topics were discussed:

- (1) Export Regulations Draft of proposed amendments. Messrs Forbes and Smaellie took part in this consideration and the following points were noted:
- (a) Draft to Comb Honey Producers! Association ag reed when revised draft becomes available.
- (b) Definition of "Honey"

It was agreed that a tidier definition could be adopted and make provision to cover Pohutukawa, Heather and similar honeys.

- (c) Re bulk honey and crushed comb honey.
- (d) Manufacturing Quality agreed that provision be made for such a classification.
- (e) Re Crushed Comb beyond original appearance.
- (f) Places of Grading define more clearly.
- (g) Times of graders availability check.
- (h) Clause 17 (1) re ownership of honey.

The H. M. A. view tended to favour the opinion that ownership changes when grade certificate is issued: it was noted that purchase contracts could specify alternatives.

(i) Clause 24 (1) re fees. The Ministry officers indicated that current

Government policy was to recover grading fees. The position relative to packers distant from grading centres was noted and it was agreed that the Association should request Government to consider such cases on a different basis.

- j) Part 2 re pollen cells and comb with a percentage of pollen. noted for further study by the Ministry.
- k) The Authority members raised the following points
  - 1) Re Grading Certificate left to Authority and Ministry to confer on possible amendments to the form.
  - 2) Moisture content
    - a) Honey 20 parts per centum
    - b) Heather honey 22 parts per centum

In this respect Codex alimentarius it was noted that the maximum moisture standard was 21 per cent for honey and 23 per cent for heather honey.

This concluded the discussion on the Honey Export Regulations.

## 2) EXCHANGE OF EXECUTIVE AND H. M. A. MINUTES

Mr Poole outlined Authority policy and attitude and indicated that Authority minutes were confidential to the Authority. This did not preclude members from discussing subject matter dealt with by the Authority, but it did place a limitation on the availability of the minutes to non members.

Mr Poole said he considered the regular newsletters to Hive Levy payers gave a reasonable coverage of Authority activities.

Mr Robinson suggested that if a copy of the H. M. A. minutes was made available on a confidential basis to the President of the Association this could meet the position satisfactorily. Mr Poole indicated the Authority would be pleased to consider such a request.

Mr Berry indicated that the Executive Committee had resolved to supply copies of its minutes to Authority members for their information.

## 3) Hive Levy Demands

Mr Robinson in raising the matter indicated that the procedures adopted this year had caused concern to a number of producers. Mr Poole explained the policy followed by the Authority and dealt in particular with the decision to impose penalty for late payment. He also said he felt that the Association should take steps to acquaint its commercial members of their responsibilities in respect of Hive Levy payments.

It was mutually agreed that a feature article be prepared for inclusion in the December issue of Beekeeper.

#### 4) Policy in Respect of the Export of Honey in Retail Packs

Mr Poole drew attention to the actual wording of the 1975 remit No. 19 which called upon the Association to make an appropriate recommendation to the Minister.

Mr Berry pointed out that the Executive had decided that before it formulated any recommendation it should first ascertain the policy attitude of the Authority towards the proposal. The Authority had sought Association view on the matter and this had been forwarded, but no reply had been received.

Mr Wicht advised that a letter under date of 3 June had been sent to the Association. (This letter was not received.)

Mr Poole then advised that further consideration had been deferred pending the return of Mr Wicht in eight/ten weeks time.

This approach was accepted as being a prudent course to follow.

In the general consideration Mr D. Hayman the Government member on the Authority pointed out that in respect of exports, the time could be appropriate for the industry to review its policies especially as these applied to

- i) The stabilisation of honey prices
- ii) Any levy to support a price stabilisation policy
- iii) The degree of control over exports and its effect on both local and export market selling.

The issues involved were basic to the future marketing of honey and it would be for the industry to make up its mind which way it wished to proceed.

A general discussion ensued without any recommendation being formulated.

## 5) Codex Alimentarius

It was decided that the Codex provisions could be accepted with minor deviations - refer page 23 (iii) of the Standard.

## 6) Conclusion of Joint Meeting

Mr Poole thanked the Executive for arranging the meeting and said his members felt it had been worthwhile and helpful to all concerned. Next year the Authority would be glad to act as hosts.

Mr Berry on behalf of the Executive thanked the Authority for attending and said he was certain that such meetings could do nothing but promote better understanding.

The Authority members then left the meeting.

#### SEMINAR PROPOSAL

The Executive discussed possible formats for future seminars with Messrs Forbes and Smaellie.

<u>Mr Forbes</u> indicated that the Ministry were quite happy to co-operate with the <u>Association</u> in organising seminars in conjunction with the Annual Conference, but did not wish to be tied each year to such a commitment. The Ministry wished to be free to organise seminars in regions as the need may arise.

In 1977 it was hoped that some of the overseas experts might well include a visit to New Zealand in their itineraries and the Ministry wished to take advantage of any opportunities that might arise in this direction.

Mr Berry advised that the Executive felt that if a seminar could be organised to coincide with the Conference it could encourage a greater attendance and also save cost both for producers and Ministry staff.

Mr Forbes emphasised that the Ministry would be glad to co-operate and suggested that the question of a seminar being timetabled into the Conference agenda be discussed at the first Executive meeting in the year - this course was agreed.

## Re Apimondia

It was agreed that the contact with overseas personnel be left to Mr Graeme Walton to organise. The question of financial assistance was also raised and it was noted that the Association was very limited in the assistance it could offer.

## BEEKEEPER

In attendance the Editor Mr Trevor Walton.

The Chairman welcomed Mr Walton to the meeting.

Topics relating to the production of Beekeeper were discussed in general terms with Mr Walton: no matters arising required Executive decision.

The meeting then adjourned until Friday 30th July 1976 at 11 a.m., venue Senior Citizens Hall Lounge.

(Minute Note: The estimated cost of the proposal will be considered at the December meeting. Where no convenient air travel is available the cost equivalent would be estimated.)

4) Funding of Branches: Information received from the Branches listed above was considered and it was decided to leave the matter over until the February meeting when a report based on the 1976 Branch Accounts could be prepared. It was also noted that a further capitation payment for 1976 was due to be made in late November.

## DISCUSSION WITH MR IAN FORBES

## ASSISTANT DIRECTOR OF HORTICULTURE

The President extended a warm welcome to Mr Forbes and said how pleased the Executive was to have him attend the meeting. The following matters were covered in the discussion

## 1) Re Apirary Advisory Service

Mr Forbes outlined the re-organisation plan for the service and indicated that the Instructors would be based at Auckland, Hamilton, Tauranga, Palmerston North (2), Christchurch, Oamaru and Gore. A Chief Advisory Officer would be appointed and based in Wellington.

The Executive discussed several aspects of the proposal with Mr Forbes and it was noted that the emphasis would be on Advisory work rather than inspection for disease.

## 2) Re Remit No. 28 - re Economic Survey

Mr Forbes indicated that there was not the resources available to mount a survey -- there were many other demands with a higher priority for economic

study. It was noted that a pilot economic study was currently being carried out in Southland.

3) Bulletin - Beekeeping in New Zealand.

The updating and re-publication was proceeding as quickly as possible.

4) Importation of Queen Bees ex Tonga

Mr Forbes advised that until the Ministry was certain no risks attended the proposal no imports would be allowed. A good deal of research was necessary.

## 5) Closed Areas

This was briefly discussed and it was noted that some adjustment to the area closed off could be recommended. Mr Robinson reported that he had been surprised at the amount of Tutu that was evident on the Coromandel.

6) Export (Honey) Regulations

The suggested amendments submitted by the Association and other interested parties had been examined by the Ministry and a clean draft would be circulated shortly.

7) Mr Forbes - also brought with him replies to the letters sent to the Ministry regarding Apiary Section staffing, the Export Regulations and the Bulletin. These were duly received.

Before Mr Forbes withdrew the President thanked him for his attendance and for the replies given to the matters raised by the Association.

## MR KEN WATERS CHIEF APPRAISER, RURAL BANKING CORPORATION

The President welcomed Mr Waters to the meeting and said how pleased the Executive was that Mr Waters had been able to accept their invitation to attend and discuss loan finance for those engaged in or wishing to take up beekeeping.

The discussion centred around the very real difficulties involved in a lender accepting "hives" as security. Mr Waters advised that the Rural Bank recognised the problem but it was really more of a legal question than anything else.

The difficulties were recognised and one suggestion that was examined was the feasibility of the Association establishing an "Indemnity Fund" to cover under-written Loan Charges for say the first five years. It would be for the Association to determine which loans should be eligible for Indemnity support.

The President in thanking Mr Waters for his attendance said it had been a most useful and valuable discussion.

It was then resolved

"THAT THE FEASIBILITY OF ESTABLISHING AN INDEMNITY FUND FOR LIMITED LOAN CHARGE UNDERWRITING BE CONSIDERED BY MEMBERS AND THAT THE MATTER BE RAISED AGAIN AT THE DECEMBER MEETING."

#### ASSOCIATION ACCOUNTS

In attendance Mr C. J. Read and Mrs Norton.

Schedules setting out the payments for August/September 1976 and a summary of expenditure to date (20/9/76) compared to budget were tabled. Mr Read and Mrs Norton replied to questions from members and it was duly moved

#### HIVE LEVY 1977

The Executive Committee gave consideration to the desirability or otherwise of recommending an increase in the Hive Levy for 1977.

After full discussion and having regard to likely cost escalation during 1977 it was duly moved

- 1) "THAT THE ASSOCIATION ADVISE THE MINISTER OF AGRICULTURE THAT THE ASSOCIATION HAS NO RECOMMENDATION TO MAKE IN RESPECT OF ANY INCREASE IN THE HIVE LEVY FOR 1977."
- 2) "THAT THE MINISTER ALSO BE ADVISED THAT THE ASSOCIATION'S BUDGETED REQUIREMENT FROM THE HIVE LEVY ACCOUNT IN 1977 WILL BE THE SAME AS FOR 1976 NAMELY \$20,000."

Dickinson/McKenzie Carried

It was further moved

"THAT THE ASSOCIATION ADVISE THE HONEY MARKETING AUTHORITY OF ITS RECOMMENDATION TO THE MINISTER OF AGRICULTURE AND REQUEST THE AUTHORITY WHEN CONSIDERING THE RATE OF HIVE LEVY FOR 1977 IT HAVE DUE REGARD TO THE EARLY CALL NEED OF THE ASSOCIATION."

EXECUTIVE SECRETARY'S MEMORANDUM 18/9/76 RE CONFERENCE REMIT REGARDING N. B. A./H. M. A. MERGER PROPOSAL

The memorandum was presented as a discussion and study paper.

It was accepted that the paper was the Executive Secretary's appraisal of the position and that the views expressed did not necessarily represent Executive Committee views or Association policy.

The question of the desirability of the Association seeking Government support for a Honey Industry Act that would embrace present Association functions plus the collection of the Hive Levy was considered and it was the consensus that this could proceed without necessarily involving the merger proposal.

It was duly moved

"THAT IT BE A POLICY DECISION OF THE EXECUTIVE COMMITTEE TO TAKE STEPS TO ESTABLISH A HONEY INDUSTRY ACT TO INCORPORATE EXISTING FUNCTIONS PLUS THE COLLECTION AND ADMINISTRATION OF THE HIVE LEVY AND ALSO MAKE PROVISION TO ENABLE THE N. B. A. AND H. M. A. TO MERGE IF AND WHEN THIS IS CONSIDERED DESIRABLE BY THE INDUSTRY. "

## DISCUSSION WITH MR IAN FORBES AND ALL APIARY INSTRUCTORS AND THE HONEY GRADER

The President welcomed Mr Forbes and the Apiary Instructors to the meeting and said it was as far as he knew the first occasion on which the Executive had met all the Apiary Advisers collectively. It was fortuitous that both had been meeting in Wellington.

The following topics were discussed informally

- 1) Re-organisation of the Advisory Service
- 2) Pollen sources
- 3) Future development and potential for expansion
- 4) Afforestation policies both in Forestry Department and Catchment Boards etc.
- 5) Liaison with Association Branches.
  - In this regard it was noted that it would be helpful if Advisory Officers were extended the courtesy of addressing members at the beginning of such meetings rather than at the end of the formal business session.
- 6) Discussion Groups the desirability of extending the use of discussion groups.

The President thanked all for participating so fully in the informal discussionthe meeting was then adjourned to enable all to go to lunch.

#### BEEKEEPER

In attendance Mr Trevor Walton.

The Executive discussed "Beekeeper" in general terms with Mr Walton and the President and members expressed pleasure at the quality journal being produced. Mr Walton expressed the hope that members keep him advised of the names of possible advertisers.

One aspect to be emphasised was the need for beekeepers to recognise their responsibilities in respect of disease. It was agreed that the Editor should confer with the Ministry in the preparation of a suitable notice for Beekeeper.

It was noted that the publication/editorial contract with A.P.A. would come up for review at the December meeting.

The question of binding the magazine into a volume was left to the Executive Secretary to examine and report.

## BEE RESEARCH ASSOCIATION RE APIMONDIA ADELAIDE TOUR FOR BEEKEEPERS

In attendance Mr Graeme Walton.

The proposals thus far were discussed and agreed. It was noted that Mr Walton would be discussing the matter further with the Executive Secretary the following day.

The suggestion that a Fund be built up from some of the travel concession allowance to assist suitable technical people to travel to New Zealand following Apimondia was favourably received. It was proposed that the fund be administered jointly.

It was agreed that the proposal be further researched.

## PRODUCTION AND INDUSTRY DEVELOPMENT REPORT

The report owed its origin to the submissions so far submitted by Branches. It was noted that many of the proposals advanced could be actioned by the Association itself; it was also noted that there was general agreement that there still existed substantial potential for increased honey production.

Clause 5 of the report dealt with Price Stability and it was resolved

## WELCOME TO MEMBERS AND VISITORS:

In opening the meeting the President welcomed Messrs Poole and Hayman to the meeting and advised that both were present as Authority members to help in the formulation of a joint Base Price recommendation to the Minister later in the day.

## BASE PRICE FOR HONEY 1977:

In introducing the subject the Chairman advised that the following factors could be included in the consideration -

- 1) to establish the form in which the representations were to be advanced
- 2) the argument and need of producers to achieve a higher level of price
- 3) the improved parity prices available to New Zealand honey
- 4) the need to adopt a new approach in respect of the basis for the Base Price
- 5) the movement in prices between local and export
- 6) the need to move away from the old unsatisfactory 'cost" basis
- 7) the need to relate interval honey prices to world markets over a reasonable period this conformed to Government Primary Product pricing policies.

The Chairman then invited Mr Poole Chairman of H. M. A. to outline the Authority's policy attitude on the question. Mr Poole reported that the H. M. A. felt the Base Price should go to 70 cents plus a further 10 cents without restriction if returns satisfied such a criteria. In general the price for honey should be related to a "realisations" base rather than the somewhat doubtful cost basis used over recent years.

The question was then opened up for general discussion. Mr Dickinson pointed out that most producers needed a higher return - it was generally accepted that the Base Price procedure had not resulted in realistic prices being set. Generally beekeepers were not in a good position to up date plant - it was an industry with a high risk factor and while recognising the need to maintain reasonable reserves, beekeepers were entitled to have a higher price and so improve individual producer viability. The impact of inflation on Reserves was another factor to be taken into account.

Mr Stuckey in commenting said most producers would agree that the local market could stand a rise in honey prices - there should be a closer relationship between parity and local prices.

Mr Clissold said he supported the comments advanced by Mr Dickinson - there was a definite need to a "realisations" pricing basis.

Mr Hayman pointed out the rises that had taken place in honey prices over the last four years - from 38 cents to 60 cents.

A number of different formulae were examined and it was duly resolved "that the following basis be advanced jointly by the N. B. A. and the H. M. A.:

"THAT THE RECOMMENDED 1977 BASE PRICE BE SET AT A MINIMUM OF 70 CENTS A KG WITH A FULL PAYOUT OF REALISATIONS TO 80 CENTS A KG, PLUS 70 PER CENT OF ANY REALISATIONS IN EXCESS OF 80 CENTS A KG. "

(Minute Note: The principal factors taken into account were

- a) Increased production costs over the last year
- b) the likely increased costs in 1977
- c) the overall effects of inflation
- d) the higher level of export realisations)

A suitable statement/memorandum in support was prepared and duly presented to Mr J. B. Bolger Under-Secretary for Agriculture by Messrs Berry and Poole on behalf of the N. B. A. and H. M. A. acting in concert.

On resuming its meeting the following day it was duly moved

"THAT THE EXECUTIVE CONFIRM THE BASE PRICE SUBMISSION MADE TO GOVERNMENT."

## REPORT ON INTERVIEW WITH MR BOLGER

The Chairman briefly reported on the outcome of the interview he and Mr Poole had with Mr Bolger. There was doubt whether a decision would be available by Christmas - generally the joint representations had been well received and he was hopeful of a favourable outcome.

The nett effect per issue would be a rise of \$300 - from close to \$1,000 to \$1,300. These figures took into account a recovery from advertising of approximately \$500 per issue.

In all 1, 100 copies were printed per issue.

The Chairman in commenting said it was necessary to first determine whether the Executive was happy with the Journal; if so then consider whether the increased production costs should be met. The consensus of view was in support of the Journal as it was being produced. It was noted that there were now over sixty overseas subscribers.
